### Deed of Surety

I hereby interpose and bind myself unto and on behalf of **HIRE ALL** as surety *in solidum* and co-principal debtor for the due payment as specified above (hereinafter referred to as "the Debtor") to **HIRE ALL** of all such sum or sums of money which may at any time be or become owing by or claimable to or by **HIRE ALL** from any cause of debt whatsoever.

I renounce the benefits of excussion and division and all other exceptions that may be raised in law against a claim by **HIRE ALL** hereunder, the meaning and effect whereof I declare myself to be fully acquainted.

A certificate issued under the hand of a director or manager of the **HIRE ALL** shall be prime facia evidence of the amount due and such certificate shall be sufficient for the purpose of summary judgement or provisional sentence.

I agree and declare that it shall always be in the absolute discretion of **HIRE ALL** without notice to me to determine the extent, nature and duration of any advances or loans of money made and/or to be made to the Debtor, to grant time or other indulgences to the Debtor, to delay the date of repayment or vary the terms of any loan, to increase the rate of interest payable thereon, to re-advance any moneys repaid, to make further advances, to release the whole or any portion of any security or to release any co-principal debtor or co-surety and to compound or make any arrangements with the Debtor. All admissions and acknowledgments of indebtedness by the Debtor shall be binding on me. In the event of insolvency, liquidation, assignment or compromise no dividends or payments which **HIRE ALL** may receive from the Debtor shall prejudice its rights to recover from me to the full extent of this guarantee any sum which, after the receipt of such payments or dividends, may remain owing by the said Debtor, provided this clause shall in no way oblige **HIRE ALL** to excuse the principal Debtor before proceeding against me and any action by **HIRE ALL** under this clause may be taken without reference to me and such action shall in no way affect, limit or prejudice me liability hereunder.

I acknowledge that this suretyship shall remain in force as a continuing security notwithstanding any fluctuation in the account and the Debtor indebtedness to **HIRE ALL** until **HIRE ALL** shall have agreed in writing to cancel the suretyship.
